Please note that curriculum used to deliver content related to Florida Statute 1003.42 on Required Instruction "used to teach reproductive health or any disease, including HIV/AIDS, its symptoms, development, and treatment..." must be approved by the district school board before use. LCS currently expects the school board to vote on approval of the proposed curriculum for school year 2022-2023 on April 25, 2023.

Should the April 25, 2023 vote result in the current proposed curriculum NOT be approved, parents will be provided with another opportunity to opt out of instruction on this topic with a new curriculum.


As part of the State required curriculum, Florida statues require students receive comprehensive health education (Florida Statue 1003.46). As part of health education for grades 6-12,-your child will receive instruction in family life and prevention and control of disease. Depending on your child's grade level, topics may include:
